**2a.) Lease of Storage Space:**

Subject to the conditions herein, Sailboats Inc. (S.I.), d.b.a. Manitowoc Marina, agrees to lease to the above Tenant, and the Tenant agrees to lease from S.I., Winter Storage in the Marina parking lot for the period from October 15<sup>th</sup>, 2010, through no later than June 15<sup>th</sup>, 2011.

**2b.) Lease of Slip:**

Subject to the conditions herein, Sailboats Inc. (S.I.), d.b.a. Manitowoc Marina, agrees to lease to the above Tenant, and the Tenant agrees to lease from S.I. Slip # \_\_\_\_\_ on Pier # \_\_\_\_\_ for the period from April 15<sup>th</sup>, 2011, through November 1<sup>st</sup>, 2011.

**3.) Schedule of Payments:**

The tenant agrees to pay S.I. a single payment of \$ \_\_\_\_\_, on or before September 15<sup>th</sup>, 2010, which represents payment in full for the Annual Contract. Payment is subject to Environmental Fee & Applicable Taxes.

**4.) Rules and Regulations:**

Tenant agrees to comply with all the Rules and Regulations attached hereto. If the Tenant fails to comply with these Rules and Regulations, this Annual Contract may be terminated by S.I. immediately, and S.I. may remove the Tenant's boat from its leased facilities. The attached Rules and Regulations may be amended during the lease term with the approval of the City of Manitowoc (City).

**5.) Liability:**

**5a.) Bodily Injury or Property Damage to Tenant.** Tenant agrees that any bodily injury or property damage to the Tenant, Tenant's boat, the contents thereof, or any other property of the Tenant in the harbor or on any portion of the Marina facilities is and shall remain the responsibility of the Tenant. Neither the City nor S.I. shall have any liability for any such injury or damage. Causes of such injury or damage shall include, but not be limited to, vandalism, malicious mischief, theft, or damages caused by wave action, storm, ice or freezing, or the conditions of dock or Marina facilities themselves. Tenant agrees to provide his own insurance against losses to property of the Tenant and hereby agrees to indemnify and hold harmless S.I. and the City with respect to any such loss or damage, even if caused by the negligence of S.I. and/or the City.

**5b.) Bodily Injury or Property Damage to Others.** Tenant hereby assumes full responsibility for any bodily injury or property damage caused by Tenant, his agents or invitees, to any persons or property, including the Marina facilities. Tenant agrees to indemnify and hold S.I. and the City harmless from any such bodily injury or property damage, and agrees to carry insurance to insure the Tenant against any such liability. Tenant shall, upon demand by S.I., provide evidence of adequate liability insurance to insure against all risks assigned to the Tenant under this Annual Contract.

**6.) No Waiver of Conditions:**

Waiver of any conditions by S.I., or the City of Manitowoc, shall not be deemed to be a continuing waiver.

**7.) Legal Clarification:**

In addition to those liens arising under state or federal law, as Vessel Owner, I grant Manitowoc Marina a security interest in the vessel, its equipment, furnishings and other appurtenances, to secure sums due under this agreement, including costs and attorneys' fees. In accordance with the lien granted, I further extend to the Marina a license to board the vessel, in the event of my default, and remove any machinery, equipment or material the Marina provided or installed. This license shall be deemed coupled with an interest and may not be revoked. Manitowoc Marina reserves the right to file a financing statement with the Wisconsin Department of Financial Institutions evidencing its security interest in the vessel at any time after consummation of this agreement.

**8.) Special Conditions:**

The Marina reserves the right to adjust slip assignments due to situations beyond its control; i.e. weather conditions, low lake levels, mechanical or structural problems, emergencies, etc. This agreement shall be in effect for the above stated period unless the dock and/or storage facilities are made unusable by storm, ice, freezing, fire or any other occurrence. Note: Manitowoc Marina basin & docks will be officially closed on November 1<sup>st</sup>, 2010. Slip extensions will not be granted after this date.
