Work List to be Completed before Launch:

SPECIAL CONDITIONS: If no specific date is given for haulout, the first available date will be assigned to that vessel. Should an owner, or his representative request to be present during haulout, and is not present at the appointed time, the vessel will be rescheduled for the next available haulout date. It is the owner's responsibility to confirm his/her haulout date and time two (2) days in advance. The Marina reserves the right to adjust haulout and launch dates and times due to situations beyond its control; i.e. weather conditions, low lake levels, mechanical problems, emergencies, etc. All requested services will be performed in a timely manner to insure the full protection of the vessel.

LEASE OF STORAGE SPACE:

Subject to the conditions herein, Sailboats Inc. (S.I.), d.b.a. Manitowoc Marina, agrees to lease to the above Tenant, and the Tenant agrees to lease from S.I., Winter Storage in/on the Marina facilities for the period from September 15th, 2010, through no later than June 15th, 2011, for the sum of \$ _____, plus applicable taxes.

RULES & REGULATIONS:

Tenant agrees to comply with all the Rules and Regulations, as well as the Environmental Management Policy, which are posted in the Customer's Lounge. If the Tenant fails to comply with these Rules and Regulations, this Winter Haulout and Storage Contract may be terminated by S.I. immediately, and S.I. may remove the Tenant's boat from its leased facilities. The attached Rules and Regulations may be amended during the contract term with the approval of the City of Manitowoc (City).

LIABILITY:

(A) Bodily Injury or Property Damage to Tenant. Tenant agrees that any bodily injury or property damage to the Tenant, Tenant's boat, the contents thereof, or any other property of the Tenant in the harbor or on any portion of the Marina facilities is and shall remain the responsibility of the Tenant. Neither the City nor S.I. shall have any liability for any such injury or damage. Causes of such injury or damage shall include, but not be limited to, vandalism, malicious mischief, theft, or damages caused by wave action, storm, fire, ice or freezing, or the conditions of docks or Marina facilities themselves. Tenant agrees to provide proof of his own insurance against losses to property of the Tenant and hereby agrees to indemnify and hold harmless S.I. and the City with respect to any such loss or damage, even if caused by the negligence of S.I. and/or the City.

(B) Bodily Injury or Property Damage to Others. Tenant hereby assumes full responsibility for any bodily injury or property damage caused by Tenant, his agents or invitees, to any persons or property, including the Marina facilities. Tenant agrees to indemnify and hold S.I. and the City harmless from any such bodily injury or property damage, and agrees to carry insurance to insure the Tenant against any such liability. Tenant shall, upon demand by S.I., provide evidence of adequate liability insurance to insure against all risks assigned to the Tenant under this Winter Haulout and Storage Contract.

(C) Legal Clarification. Manitowoc Marina warrants its work for six (6) months following completion, provided the Marina is notified within such period of any defect and the vessel is brought to the Marinas' facility for repair. However, the Marinas' limited warranty does not extend to any machinery, equipment or material manufactured or supplied by others. Any implied warranties, including any warranty of merchantability, fitness for particular purpose or seaworthiness, are limited to the duration of the Marinas' warranty. Manitowoc Marinas' warranty is limited to the actual invoice amount covering the work that was performed.

In addition to those liens arising under state or federal law, as Vessel Owner, I grant Manitowoc Marina a security interest in the vessel, its equipment, furnishing and other appurtenances, to secure sums due under this agreement, including costs and attorneys' fees. In accordance with the lien granted, I further extend to the Marina a license to board the vessel, in the event of my default, and remove any machinery, equipment or material the Marina provided or installed. This license shall be deemed coupled with an interest and may not be revoked. Manitowoc Marina reserves the right to file a financing statement with the Wisconsin Department of Financial Institutions evidencing its security interest in the vessel at any time after consummation of this agreement.

This agreement shall be in effect for the above stated period unless sooner terminated by destruction of facilities by storm, ice, freezing, fire or any other occurrence. Note: Manitowoc Marina basin & docks will be officially closed on November 1st, 2010. Slip extensions will not be granted after this date.

I have read, understand and authorize the above work to be completed by the Manitowoc Marina. By providing a haulout date above, I have authorized Manitowoc Marina to haulout my vessel and move it to its Outdoor Winter Storage location in the facilities parking lot. I expect to be charged, and agree to pay, the appropriate charges for these services, in addition to the published Storage fee.

Terms are effective 7/1/2010 and are subject to change without notice.
